Dear DBMAT families and the professionals who serve our DB family members,

Our DBMAT Conference Committee has been busy planning the Annual Family Conference for 2018 and it will once again be held at Camp Young Judaea (CYJ), in Wimberley, Texas. The DBMAT Annual Family Conference is scheduled for September 14-16, 2018.

With our Family Conference being held at Camp Young Judaea (CYJ), there are a few rules that must be followed by all attendees, or Camp Young Judaea reserves the right to terminate our contract for future years. Here is the main rule that we ask everyone to follow:

1. Camp Young Judaea is a Jewish facility located in Wimberley, Texas. CYJ hosts a variety of organizations during the spring, fall and winter months and are extremely accommodating, but they require that their dining hall, kitchen area and attached meeting hall (this is just one building) remain “kosher” at all times. This means that **absolutely no food or drink of any kind** can be brought into the dining hall/kitchen area or main meeting hall at any time during the weekend. Note: This includes gum, candies, mints, and outside drinks etc.

CYJ will be preparing all of our meals on-site in their kitchens and will see to it that the “kosher” standard is followed. Drinks will be located in the cafeteria and DBMAT will be placing CYJ approved “kosher” snacks on the tables in the meeting hall for everyone to enjoy. Please feel free to help yourselves to the snacks on the tables. CYJ is very excited to have DBMAT back for a 5th year and we are all willing to help make this year as easy as possible.

Note: You are welcome to bring any special foods or drinks for you or your family members, but it must be kept either in the parent’s room or the Nurses’ Lodge. It cannot be brought into the dining hall/kitchen or meeting hall.

IMPORTANT: Forms

Registration by the **deadline of August 25, 2018** is mandatory to attend this learning weekend. The **Conference Registration Form** must be filled out by both the families and the professionals who plan to attend. The **DBMAT Child Information Form and Weekend Medication Sheet** *must be completed* by the parent(s)/guardian(s) **for each child/family member (disabled & sibling)** you plan to bring and have listed on the registration form. **(Please make copies of these forms and complete one for each child.)** All campers must be accompanied by a family member or guardian. If your child/family member is a client of HHSC Blind Children’s Program or Texas Workforce Commission (TWC), please clear your travel reimbursement & registration fee with their Program Specialist before registering for the conference.

Note: If you plan to bring a nurse, attendant, or any individual who is **not a family member** to care for your disabled child/family member during the weekend, please be sure to include the individual’s name and phone number on the **DBMAT Child Information Form**. A background check is required on anyone caring for your child/family member who is not a family member.

On-Site Check-In

On-site check-in is required on Friday Night, between 6 - 10 P.M., for all participants planning to stay on the campgrounds. In order for families to complete the intake process, you must plan to arrive on site **after 6 P.M. and prior to 10 P.M.** In consideration for the other families, check-in volunteers, childcare workers and nurses, this ruling must be courteously followed. There will be a sandwich/snack available for everyone between these hours. *****Please note childcare will not be available until 8 p.m.**** This will allow all volunteers to check-in and be available for campers.

Accommodations

Camp Young Judaea, located in Wimberley, Texas, is a lovely campsite that offers various sleep accommodations. Please be prepared to share these air conditioned rooms with others. If you choose to stay offsite, your room accommodations are at your own expense. Rooms, meals and childcare are furnished onsite for families. Families are encouraged to opt for the 24-hour respite care available. Rooms and meals are also provided to professional participants onsite.

Creature Comfort

Although there are various sleep accommodations with A/C, this is a campsite! Camp Young Judaea is accessible with designated vehicle parking areas. **Drop-off and registration will be available in the main building located in front of the circle drive.** There is limited outdoor lighting so **please bring flashlights to maneuver after dark.** Be prepared to bring pillows, sheets, blankets, towels, face cloths, soap, shampoo, casual clothing and closed-toe shoes for yourself and each of your family members. The child/family member

campers who will be with the childcare workers will also need to bring swim suits, sun block and swim towels. **(Be sure to pack the belongings for those staying in the 24 Hour Kid Kamp separately.)** Be prepared to use an alarm for your awakening. We start our activities **early** each morning with a family & friends breakfast. Bring any other special items you or your campers need, particularly their medications, instructions, toys, napping stuff, etc.

DBMAT CHILDCARE

Workers: Childcare workers will provide care for your child/children during the weekend so that you may attend the conference and have social time with other parents and professionals. All workers have background screenings and are knowledgeable through education, employment or family experience. (Yes, we have a few siblings that come with their unique experience and skills). Our focus is care, safety and FUN! **Childcare begins at 8:00 PM Friday and will continue till the end of the conference.**

Activities: The children will be engaged in fun outdoor activities in a camp setting. The camp offers a basketball court, playground area, arts & crafts room, swimming pool with a slide and lots of games. An air conditioned indoor area is set up with mats and toys for the infants and toddlers. Please bring a playpen, blanket or special toys that your little one may want or need.

Childcare groups:

- **Infant/Toddler Day Care:** Infant – 3 years have supervised activities with toys and outdoor fun. Parents are requested to bring toys that their child likes. Children will sleep with their parents.
- **Day Activity Kid Kamp:** 4 years and older participate in group activities including basketball, playground fun, arts & crafts, swimming and lots of games. Children will sleep with their parents.
- **24 Hour Kid Kamp:** 4 years and older participate in group activities including basketball, playground fun, arts & crafts, swimming and lots of games. Children will sleep with childcare workers in cabins that are within walking distance of the adult sleeping areas.

Cabins: Children will be assigned to workers in cabin groups. Cabins are integrated with your children who are disabled and their siblings. Groups are made with consideration to gender, age, and activity level. Use the back of the Child Information Form to make special request such as friends who want to be together, etc

Parent Contact: During the weekend, the workers and nurses try their best to not bother parents during meeting times. We want you to have this time to focus on learning, sharing information, connecting with other parents and socializing. If it becomes necessary to talk to parents, Gay will send a text message asking a question or requesting you to meet at a specific place. Be sure to include your mobile number on the Child Information Form.

Dining: There will be two dining areas at the camp. Only kosher food is allowed in the main dining room area. If your child needs special food that is not kosher or food that you have made at home, he/she will eat in the dining area at the nursing lodge. Their food can be stored in the nursing lodge that comes equipped with a refrigerator and microwave. Food can be brought from the main dining area to the nursing lodge if necessary.

Pictures: One of the workers will be assigned to get pictures of your child during the weekend participating in activities. If you bring a flash drive, your pictures can be uploaded and ready for you to take home.

Nursing care: Nurses will be at camp to provide first aid, administer medications, treatments, tube feedings, do catheters etc. Although there will be a nursing lodge, it is not stocked with medical supplies other than a basic first aid kit. Please bring all necessary supplies that your child will need for the weekend.

Medication and Equipment:

Parents must bring all medications including PRN's and any medical equipment that your child/children will need. This includes but not limited to: applesauce or pudding (if needed to take meds), nebulizer machine, oxygen, inhalers, g-tube supplies (including extra g-tube/button if needed), suction, suction catheters, saline, urinary catheters, tube feedings/formula, prosthesis, hearing aid, basic hygiene items, bedding, diapers, dressing supplies, diabetic supplies, etc.

EPI (Epinephrine) Pen

This is in an outdoor setting so if you or your child has any allergy that may be life threatening (anaphylactic) whether it is food, animals, bugs/insects etc. Make sure you bring your EPI (epinephrine) pen. It is better to be prepared than not to have it if needed. The nurse will work with you on meds, treatments etc.

Prescription Medication

Bring medications in the original medication bottles from the pharmacy if they are prescribed from a doctor. Nurses cannot give medications that are in baggies, etc. It is fine to separate medication in box/med minders but it is still necessary to bring the prescription bottle so medication and dosage can be verified.

Child Care Information Form:

- Make as many **copies** as you need. Complete a Child Information Form for each child (disabled or sibling).
- Use ink and print the information clearly.

Weekend Medication Form

- Make as many **copies** as you need. Complete the Weekend Medication Form for each child (disabled or sibling).
- Use ink and print the information clearly.
- The nurses will review the form when you register at camp so do not be concerned if the medication changes after submitting this information.
- List all medications that you will be bringing for your child. Include: name, dosage, frequency (how many times per day), route (by mouth, per feeding tube etc.).
- In the space provided, list the times you give medication. The nurses will try to administer medication as close to the time given as possible. Times may vary to coordinate the schedule, groups, and number of children. If it is essential for the medication to be taken at a certain time, specify that at the bottom of the form and explain.
- If you have special instructions, use the space provided and the back of the form.

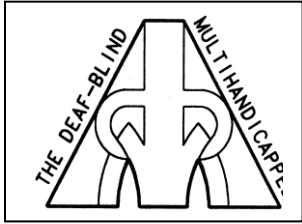
