Tammy Martin is the head of the Children's Program. The change with Transition Program moving to age 14 will be effective on October 1, 2017 – More to come in our next newsletter about what this will all mean. Here are some updates:

Blind **Children's** Vocational Discovery and Development Program is now under Texas Health and Human Services Commission. Any referral who is visually impaired or blind ages 0 through 9 can be sent to this program. For more info call 1-877-787-8999.

The Transition Program that served visually impaired and blind youth ages **10** through age **22**. This program is now under Texas Workforce Commission. For more info call 1-800-628-5115.

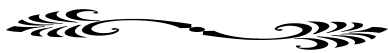
The Vocational Rehabilitation Program serves visually impaired and blind **adults at any age** who want to retain or gain employment. This program is under Texas Workforce Commission. For info call 1-800-628-5115.

The Older Individuals who are Blind program serves visually impaired and blind adults age **55** and older who want to maintain an independent life and are not interested in employment. This program is under Texas Workforce Commission. For info call 1-800-628-5115.

The Independent Living Services Program serves visually impaired and blind adults **under the age of 55** who want to maintain an independent life. This program is provided through local Independent living Centers and referral information can be accessed at:

Taking the Time to Talk

"Cogswell-Macy Act"

In October 2015, Orion and I, during a NIH-NEI* deafblind gene research visit, we were blessed to be able to meet dear old friends from our Maryland days and pay a visit to a legislative aide in Senator Cornyn's office to share information about the Cogswell-Macy Act. Barbara Raimondo, the CEASD** government relations liaison, and an ASL interpreter met with me outside Senator Cornyn's office. We strolled Orion in with a local volunteer intervener as well. Orion knew that we'd do fine so he took a nap in his stroller at the table as Barbara explained to the aide about the Cogswell-Macy Act

and I shared examples of experiences of our Texas families of DeafBlind children.

One example from my family's experiences was that we had to move to another state halfway across the country to Texas, to get Orion appropriate services, particularly intervener support, as he grows up through the educational system. We sure kept the aide busy writing notes in her notebook. Her pen even dried out during the process!



We need to make sure to bring extra DBMAT "ILY" (I love you) handshape pens for future opportunities like this!

Time has passed without a single senator in our nation stepping forward to sponsor the Cogswell-Macy Act. We need to continue to try even after our National Advocacy Day efforts at the US Capitol Building on March 2, 2016 with Melanie Knapp and Vivecca Hartman, the National Call-In Day April 14, 2016, and the Texas Call-In Day on July 28, 2016. It felt like a miracle that during fall 2016, U.S. Representative Sheila Jackson Lee (Houston area) stepped forward in support of the Cogswell-Macy Act. This may just be the first leak in the dam.

Another possible opportunity we have is when the Individuals with Disabilities Education Act (IDEA) needs to be re-authorized, we can specifically push

for the components of the Cogswell-Macy Act to be incorporated into IDEA at that time. Our US-level legislators will hopefully have prior knowledge from our tireless visits, e-mails and phone calls.

Keep it up, awesome and loving Texas families!

Alice Cogswell and Anne Sullivan Macy Act (H.R. 3535)

Named for the first deaf student to be formally educated in the U.S. and for Helen Keller's beloved teacher, respectively, the Alice Cogswell and Anne Sullivan Macy Act will strengthen the Individuals with Disabilities Education Act to improve results for deaf, hard of hearing, blind, visually impaired, and deaf-blind children, including those with additional disabilities.

On September 17, 2015, a comprehensive **Bill** to reform the education of deaf, hard of hearing, blind, visually impaired, and deafblind students was introduced in the U.S. House of Representatives. Sponsored by Congressmen Matt Cartwright (D) and David McKinley (R), H.R. 3535, the Alice Cogswell and Anne Sullivan Macy Act, the bill will amend the Individuals with Disabilities Education Act to address the unique needs of these populations. This is truly a historic event.

The Act includes 3 sections. Title I addresses issues specific to the education of children who are deaf/hard of hearing, Title II addresses issues specific to the education of children who are blind/visually impaired, and Title III addresses issues specific to the education of children who are deafblind. begins on page 40 of the Act and includes wording which:

- Designates intervener services in the "related services" listing
- Reflects the need for the recognition of and training for teachers of the deafblind
- Adapts the federal definition of deafblindness
- Requires each state to specifically address deafblind issues in the development of its state plan

The Alice Cogswell and Anne Sullivan Macy bill now needs to gain the sponsorship of many more House members, and it needs to be introduced in the Senate. **Please take a few moments to contact your Congressional members to ask them to sponsor this bill either by phone or email.** You can find your state [Senators by clicking here; http://intervener.org/wp-content/uploads/2015/10/BILLS-114hr3535ih1.pdf](http://intervener.org/wp-content/uploads/2015/10/BILLS-114hr3535ih1.pdf)

If you choose to call, follow these steps:

1. Call the Capitol switchboard at [202-224-3121](tel:202-224-3121). The Leadership Conference on Civil Rights provides great information to help you in telephoning your Representative; http://civilrights.org/action_center/resources/calling-congress.html
2. When someone answers (or if you reach an answering machine) identify yourself and let them know you're a constituent.
3. Ask your member of Congress, and their staff whom you're likely to speak to, to co-sponsor the Cogswell-Macy Act – H.R. 3535, and ask him/her to get back to you with a response. Have you ever tried to find a qualified intervener? It is very difficult to find one as there are not very many of them. DBMAT offers scholarships for the Intervener classes for people who work with our kids.

It's just very difficult to find that special person and then getting them to stay. The biggest problem is that the wages have not been increased with the cost of living and minimum wage since our bills passed around 10 years ago. Even if you go Consumer Directed, it is not much money for the experience they have to have. McDonalds in our city start paying at \$12.50 an hour. When the oil industry picks up more the wages will go up more! Money is a BIG incentive!

We all need to visit our State Legislator. Get to know them and their aids. Take your child to visit them in their office and let them get to know you. Write a one page story about your child and attach his or her picture to it. The more they get to know us...they will remember you next session. This session is not a good time to try to get wages increased since they have already cut all state agencies by four percent. If we get to know our legislators now, then next session we can approach them **to increase the Intervener wages.** This is how we accomplished getting our bills passed last time.

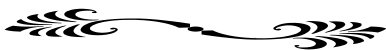

Jason possessed strength, perseverance, and an ability to overcome incredible odds and physical challenges. With his courage, he led us to believe that each day is

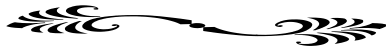

Whether Jason was enjoying a cup of coffee with milk and a "little sugar" and his 1 – 2 – 3 cookies or helping granny cook (if he could "lick" the spoon), he always had his cap on. He enjoyed spending the night at hotels and eating at his favorite restaurants. He could quickly finger-spell out his favorite places. He spent many summers at Camp Summit horse-back riding and swimming.

With Jason's passing we remind others that his life is one to be celebrated. Although we will miss him everyday, especially his winning smile, he will forever remain in our hearts. Through his teachings about life, we were able to create wonderful memories and it has been a privilege to be his granny and grandpa. Jason leaves behind many wonderful caregivers and teachers that provided love and support that enhanced his quality of life. DBMAT Committees: DBMAT loves to have new ideas and other people’s involvement! We are most effective, when we divide and conquer our time and talents! In order to assist us in being able to do this, we have focus group committees that you can select one (or more ☺) to join. They are not all as active as others. Legislative: To obtain and share legislative (both state and federal) information that affects people who are deaf blind and multihandicapped with the whole group. When there is action to be taken, where DBMAT may have an impact, this committee can organize and plan an approach for all to be able to participate.

Fundraising: To organize and communicate fund raising tips for all to participate in.

Conference Planning: To organize and plan the annual conference. The majority of the work for this committee is via conference calls starting 6 months prior to each annual conference.

Education: To organize ideas that are good for sharing amongst our families. Based on each family’s experiences and tips and tricks learned, one of the goals of this committee is to have a web-based place for knowledge sharing.

Regional Coordinators: To have a DBMAT member in each region of Texas as a contact person for any new locals that want to reach out and talk to someone close by.

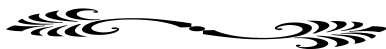
vocational and independent living opportunities of these individuals for all ages.

Vision — DBMAT recognizes that people who are deaf-blind multihandicapped will benefit from the provision of Quality Intervener Services lifelong. When intervener services are provided from the age of diagnosis, the person who is deaf-blind multihandicapped is most likely to develop to their full potential with an abundance of “Moments of Joy”, (as defined by Dr. Jan van Dijk). As the person who is deaf-blind grows, his/her needs will change, but quality intervener services will always be required.

The DBMAT Board recognizes their primary goal is to advocate for quality Intervention to be available to all deaf-blind individuals who could benefit from it, until it is a viable option legally allowable to all who want to request it. The commitment to this goal began during their Board meeting, held on June 9, 2006 and continues to be a primary focus today. In addition to the primary goal, we advocate for all deaf-blind individuals to have access to the services applicable for their individual needs.

It is DBMAT’s vision to provide to individuals who are deaf-blind multihandicapped, as well as their families, access to other members, training opportunities, social events, as well as resources for which we maintain or have the ability to direct our members to.

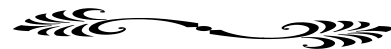

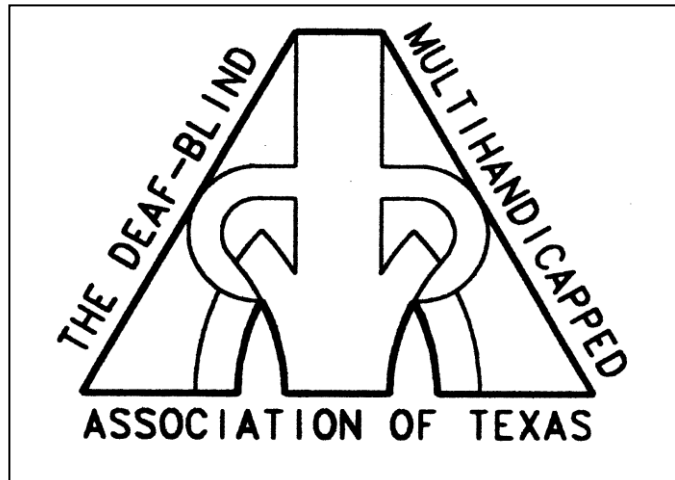
